Survey Says...

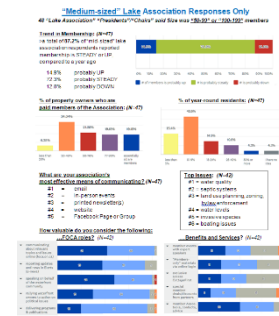
FOCA 2018 Cottage Country Survey

Vote for your Future

Vote day: October 22, 2018

Remember that you are entitled to vote in Ontario Municipal elections wherever you or your spouse owns property. **That means you might be voting in more than one location this month!** (Click the image at right to visit FOCA's Facebook post, ready for sharing with friends who might need to be reminded of this.)



According to Ontario's Municipal Elections information, your name must be **on the voters' list** in order for you to cast a ballot. And:

After September 1, you must apply to your municipal clerk if you want to add your name to the list or correct your information. You have until the close of voting on October 22 to apply for any changes. If you are applying to add your name to the voters' list, you will be asked to provide proof that you are eligible to vote. FOCA suggests you start by finding the link to your Township/Municipality here: <http://www.mah.gov.on.ca/page1591.aspx>, then look for posted "Election information" on your Municipal website, to learn about your local voting options (in person, internet, mail-in, telephone...) To confirm you are on the voters' list, find the contact information for the Clerk on the Municipal website, or call the Township/Municipality's main contact phone number for further assistance.

REMEMBER: Your vote matters!

ECO report on Climate Change

On September 25, 2018 the **Environmental Commissioner of Ontario (ECO)** Dianne Saxe released the ECO's annual report on climate action in Ontario. The report lays out the known impacts of a warming climate, which include flood events and the related impacts to rivers and lakes. The Commissioner emphasized that the province must have climate change laws that drive down emissions while funding sensible solutions. "It will cost much more if Ontario doesn't start getting ready, and no one is sure who will pay," said Saxe. ***Climate Action in Ontario: What's Next?*** can be downloaded here:

- other innovations or successes in line with FOCA's mission, *"To protect thriving and sustainable waterfronts across Ontario."*



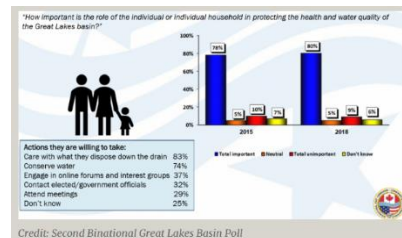

Results of IJC 2018 Great Lakes Survey

The **International Joint Commission's** Great Lakes Water Quality Board has released survey results that **88%** of over 4,000 Canadian and US respondents believe protecting the Great Lakes is important. Top on the list of potential negative impacts? Invasive species, followed by algae blooms. Another species to watch for: Starry stonewort

FOCA members on Stoney Lake in the Kawarthas have recently reported sightings of **Starry stonewort**. Although it looks like an aquatic plant, it is, in fact, an alga that grows tall and dense, forming floating mats that can interfere with recreation and displace native plant and fish species. Starry stonewort has been the subject of much concern on Lake Scugog in recent years, where it has been researched by the [Scugog Lake Stewards](#) together with the University of

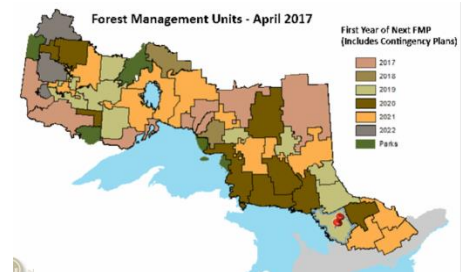

Celebrating a Golden Anniversary

Last month, FOCA received the following update from our member group:

*Family and friends of the **Bagot Long Lake Cottage Association** (Calabogie) gathered on September 2, 2018 to celebrate 50 years at our beautiful lake. In 1968, the Ontario Department of Lands and Forests, released 25 Crown land lots for sale on Bagot Long Lake, with the stipulation that, "To qualify for patent, an applicant must within two years of the date of sale, construct a cottage on the site having a minimum value of \$1000.00, and a minimum floor space of 320 square feet."*

The original pioneer families were ambitious. Without the luxury of a road or hydro, the property owners had to boat or hike through forest in order to access and clear their lot. They had to get building materials to their property and diligently work with Lands and Forests, contractors, and collect communal money for construction of the Bagot Long Lake Road (completed 1969). Hydro lines and service arrived 1969-1970.

Fifty years later, 10 of the original pioneer families (or descendants) still embrace Bagot Long Lake. The Cottage Association is a supporter of Calabogie, the Calabogie Volunteer Fire Department, and a long-time member of FOCA and the Lake Partner Program.
